Dear HCNC Friends,

As most of you know Ron Horn decided to resign from the position of President of the Club on September 14th. His letter also informed you that Megan Morrison had resigned from the Secretary position the week before on September 8th.

More recently Melissa Lundgren, Marsha Petry, Jeff Ashworth and Kathy Sylvia have also resigned from the Board of Directors. In the roughly 2 years I have been on the Board, each of these members has contributed greatly to our club. As Treasurer, Melissa modernized our books and record keeping and worked tirelessly to keep the board informed of the financial position of the club which has gone from declining to increasing revenues. Marsha has volunteered at every water test I have attended. In addition she built and donated new water markers for the water tests which the club now owns. Jeff helped organize a very successful draft test (the first outside of Colorado) and has been instrumental in updating and maintaining the club website as well as administration of the HCNC Facebook page. Kathy is the premier working event secretary in the country. I had the privilege of working with her in organizing the July water test this year-which was the club's first full test. In addition she has mentored numerous other members in conformation, draft and water- a true asset to our club. Megan has been instrumental in increasing the club's visibility through Facebook as well as chairing last year's very successful September Water Test. She has also brought new ideas and enthusiasm to the club that was much needed. Ron has been involved with club leadership for over 2 decades. I think he is most proud of his work with Therapy Dogs at Craig Hospital. Seeing our dogs make a difference and make a connection with brain injury patients is pretty special. I also know that he has contributed greatly to the club's working events (chairing, stewarding, mentoring, & judging) for many years. I want to personally thank all of these members for their service to the club.

The Club really does owe all of them a debt of gratitude.

But I'm sure the recent board resignations are leaving a great deal of doubt and many questions among the membership. How will we proceed? What needs to be done?

Claudia Walters and I are the remaining Board Members. We have consulted with the NCA, our parent organization. As Vice President, Claudia will serve as acting President and we have agreed that in accordance with our bylaws we will choose the new members of the board. This will be done at an upcoming meeting.

Article III Section 3 states:

"Any vacancies occurring on the Board or among the Officers shall be filled for the unexpired term of the office at the first regular meeting following the creation of the vacancy or at a Special Board Meeting called for that purpose."

In short vacancies on the board are filled by a vote of the remaining board members. Claudia and I have consulted and will jointly nominate and name the new board members. We take this duty seriously and will be looking to build a Board committed to continuing to build the club's membership and to producing quality and fun events for all of the members.

In Article II Section 3, our bylaws read:

"Board Meetings may be held in conjunction with club meetings, or called by the President or a majority vote of the Board. Notice shall be sent to members as set forth in paragraph one (1) above. These meetings shall be conducted a minimum of four (4) times per year. A quorum is the majority of the Board."

In accordance with the bylaws, Claudia and I are announcing a Board Meeting scheduled for October 19th in Highlands Ranch and since we are the only remaining board members - we are the majority of the board and therefore a quorum.

As I stated above, we owe the former board members thanks for their contributions to our club. The club's finances and participation from membership are as strong as they have ever been. But our leadership is at a turning point. We need members who are willing to get involved in leading the club and show initiative in producing events. Paying your dues is not enough. The club can't be fueled by dues alone, we need new blood in our leadership. In order for the club to be successful, the membership and the leadership must combine to be an effective force in generating events that are compelling to attend. Quite frankly we need leadership who is willing to bring new ideas and will be accountable for the direction of the club.
